The County Government of Kilifi wishes to make amendments to the bid document as indicated below:

- (i) Section II -Instruction to tenderers, Pre-tender meeting No. 15 is amended to read;  
**15.1** There will be a pre-tender bidder's conference meeting on 1<sup>st</sup> August, 2019 at 1000 HOURS at Kilifi County Treasury Hall. The tenderer's representative ought to be a technical person with the relevant background Knowledge should come with a national identification card or passport and an introductory letter of the bidder. The purpose of the meeting will be to clarify issues and to answer questions on any matter that may be raised during bid preparation.
- (ii) Section III – Appendix to Instruction to tenderers, Instructions to tenderers reference **13** is amended to read;  
Tender Security of **Kenya Shillings One Hundred Thousand (Kshs. 100,000.00)** in form of a Banker's guarantee or an Insurance Company Guarantee issued by an insurance firm approved by the Public Procurement Regulatory Authority (PPRA), cash, letter of credit or guarantee by a deposit taking microfinance institution, Sacco society, the Youth Enterprise Development Fund or the Women Enterprise Fund valid for 120 days from the date of tender opening in the format provided in the tender document (**Mandatory**).
- (iii) Section III – of Tender No. **KC/002BF/2019/2020/2021**: Appendix to Instruction to tenderers, Instructions to tenderers reference **11 (v)** is amended to read;  
Certificate of Registration with the National Construction Authority (NCA) under Water works Engineering **NCA 4** and below (**MANDATORY**).
