- c) For Building Works attach a Photocopy of current registration certificate(NCA 7) & Energy Regulatory Commission (E.R.C)Category 'Class B' and above (For Electrical Domestic sub- Contractors)
- d) For Building works attach a letter of commitment from the Electrical Domestic Sub-Contractor nominated by the main contractor indicating that they have been duly consulted, priced the Bills and are willing to execute the sub-contract as domestic subcontractors
- e) The Bid Bond of 2% of bid price in form of bank guarantee from a reputable bank or approved insurance firm and must remain valid for 150 days from the date of tender opening.
- f) Valid Tax Compliance Certificate.
- g) Valid PIN and VAT Certificate.
- h) Form of Tender Must be Filled and signed.
- i) All tender documents attached must be electronically ,serialized and initialed.

Tender documents registered in our tender document issue register shall qualify to tender, prices quoted should be inclusive of all Government of Kenya taxes and delivery costs and must be in **Kenyan shillings**.

Price and Quantity discounts MUST be indicated in the summary page if any.
