REQUIREMENTS /CONDITIONS FOR AMUSEMENT MACHINE/POOL TABLE PERMIT:

1. The proprietor must be over 18 years of age with valid identification document
2. The owner must have a certificate of good conduct
3. The business must be registered (Pool Tables are exempted)
4. Letter of no objection from the ward administrator
5. Letter of no objection from the Officer Commanding Police Station.
6. For those renting premises , a letter from the land lord/lady
7. Proof of purchase of the machine or pool table- Amusement Machine should state:
 - a) Manufacturer (serial no. is a must)
 - b) Country of origin
 - c) Year of manufacturing-should not be more than 3 years old
8. The premises where amusement machines should strictly be for the machines only, and should not be less than five in number.

NB: The premises should not be accessible to persons under the age of 18 years and /or school going children.
9. All the documents must have 2 copies each, plus originals which must be handed back to you immediately after verification.
10. During the validity of the permit an attendant should be present at place of work, and must adhere to all set rules by the County Government of Kilifi.
